INTRODUCTION OF RESOLUTIONS

Senate Resolution 10

Relating to commending President Nixon for concluding the conflict in Vietnam.

Whereas, at the time of his inauguration in 1969, President Richard Nixon took office faced with the immense problem of United States' involvement in the Vietnam conflict; and

Whereas, in the past 4 years the President has continuously reduced the role of the United States in this conflict by reducing the number of American troops from over 500,000 to the present level of some 20,000; and

Whereas, after long, delicate and trying negotiations, President Nixon has succeeded in bringing about an end to American involvements in the conflict in Vietnam; and

Whereas, the settlement has been just and honorable, and consistent with the principles for which the original commitment was made; and

Whereas, the agreement secured by the President will enable the return of American prisoners of war, including many young men from Wisconsin who will at long last be able to return to their families and loved ones; and

Whereas, President Nixon, the late President Lyndon Johnson and others endured vilification as men of war while earnestly seeking a just and lasting settlement of the Vietnam conflict; and

Whereas, this achievement by the President is of great significance to the people of Wisconsin and the nation, who have a deep and abiding respect and desire for peace; now, therefore, be it

Resolved by the senate, that President Nixon is hereby commended for bringing about an end to the Vietnam conflict and guiding the nation to a new era of peace and prosperity; and, be it further

Resolved, That those courageous individuals who were forced to bear undue vilification as they sought to honorably resolve the Vietnam conflict to the best of their ability; are also commended and, be it further

Resolved, That the senate chief clerk prepare a citation bearing this resolution to be delived to President Richard M. Nixon.
