Directing the senate committee on industry, labor, taxation and banking to study the business and industrial climate in Wisconsin.

Whereas, the economy of this state is not expanding at a rate sufficient to meet the employment needs of a growing work force; and

Whereas, this state is not doing enough to attract new firms, to encourage existing firms to expand within the state or to prevent critical firm closings and relocations; and

Whereas, 1971 and 1972 saw 64 firm closings in the state, with a resultant loss of 10,400 jobs, while state government employment mushroomed with 6,400 new positions; and

Whereas, it is in the best interests of the citizens of this state to meet employment demand by increasing the number and quality of new and existing jobs in the private sector, and not through governmental expansion; and

Whereas, the senate has an affirmative duty to examine responsible methods of expanding economic opportunities and providing productive jobs for all members of this state's expanding work force; now, therefore, be it

Resolved by the senate, That the senate hereby directs the senate committee on industry, labor, taxation and banking to study Wisconsin's business and industrial climate, reviewing such matters as taxes, governmental attitudes, labor costs and transportation; and, be it further

Resolved, That the study shall include public hearings at times and locations designated by the committee chairman, and that accurate records shall be kept, and that the committee shall report to the senate by June 1, 1973, all findings and recommendations for promoting business, industry and job opportunities within our borders.
