INTRODUCTION OF RESOLUTIONS

**Senate Resolution 17**

Directing the senate committee on industry, labor, taxation, and banking to investigate the energy crisis as it affects Wisconsin.

Whereas, a continuous and sufficient supply of petroleum products, natural gas, and electric power is required to meet the housing, recreational, transportation, and commercial needs of the people of Wisconsin; and

Whereas, last winter's fuel oil shortage threatens to recur during future heating seasons; prospective consumers of natural gas are denied supply; and recent predictions indicate a possible gasoline shortage with resulting price increases, gas rationing, and adverse effects on Wisconsin agricultural economy; and

Whereas, fuel oil and natural gas shortages threaten the state's electric power supply; and

Whereas, recurring warnings of an impending energy crisis have not been met with conclusive investigation and necessary program directives; and

Whereas, the senate has an affirmative duty to examine current and future conditions affecting the supply of energy to state residents, and to develop policies which will solve existing energy problems and avert shortages in the future; now, therefore, be it

Resolved by the senate, That the senate hereby directs the senate committee on industry, labor, taxation and banking to study the energy producing industries, in all stages of production, transmission, and delivery, in so far as they affect Wisconsin's energy supply, and grants the committee powers to subpoena witnesses and compel testimony; and, be it further

Resolved, That the study shall include public hearings at times and locations designated by the committee chairman, and that accurate records shall be kept, and that the committee shall report to the senate no later than September 1, 1973, with all findings and recommendations for assuring supply of petroleum products, natural gas, and electric power to Wisconsin consumers.
