INTRODUCTION OF RESOLUTIONS

**Senate Resolution 20**

Directing the senate committee on transportation to develop legislation for a new type of vehicle registration and title.

---

Analysis by the Legislative Reference Bureau

This resolution directs the senate committee on transportation to develop legislation for a new type of motor vehicle registration and title and introduce the legislation no later than February 1, 1974. The resolution lists 2 possible methods the committee must consider.

---

Whereas, a new type of vehicle registration and title, utilizing a form similar to the type mentioned below, will greatly aid law enforcement agencies throughout the entire state by making the tracing of abandoned or junked vehicles less complicated and time consuming; and

Whereas, such new type will aid in the proper taxing in regard to sales of vehicles, and accuracy in ownership of vehicles; now, therefore, be it

Resolved by the senate, That the senate committee on transportation shall develop legislation for a new type of vehicle registration and title and shall introduce such legislation no later than February 1, 1974; and, be it further

Resolved, That such committee shall consider in its study the following possible methods:

1) The same title as we presently utilize could be placed on NCR paper. When ownership is transferred, the original owner and the purchaser would complete the title, but the new owner would be required to forward the original to the division of motor vehicles and the seller would be required to forward the NCR copy within. In this manner, ownership and transfer of ownership could be continuously controlled, as could accurate collection of state sales tax.

2) Again, the same title as we presently utilize could be used, but an additional section would be placed on the bottom of the title and attached by a perforated line. The same principle would be followed, except that the original owner would be required to fill out the bottom section of the title, tear it off and forward it to the

division of motor vehicles. This, again, would assist in maintaining ownership and transfer of ownership and also for the accurate collection of state sales tax. In this manner, continuous ownership of all vehicles registered in this state, or titled in this state, would be controlled and tracing of any motor vehicle would be simplified and the accurate and continuous collection of the sales tax would be accomplished.
