### **Senate Resolution 23**

To amend senate rule 26 (1), relating to notice of public hearings.

---

### Analysis by the Legislative Reference Bureau

Under present rules of the senate, notice of a public committee hearing must be filed on or before 2 p.m. on Wednesday of the week prior to the week during which the hearing will be held. This resolution requires such filing to be on or before Monday instead of Wednesday. Notice of hearing may be filed by 2 p.m. on Wednesday of the second week before the hearing if posting of an advance notice is desired.

The content of this proposal matches a rule change adopted on May 22, 1973, under 1973 Assembly Resolution 26.

---

Resolved by the senate, That:

SECTION 1. Senate rule 26 (1) is amended to read:

Senate Rule 26. (1) The chairman of each senate committee shall, on or before ~~Wednesday~~ Monday at 2:00 p.m. of each week, file with the chief clerk a list of the public hearings on measures before his committee which will be held during the following week, which lists shall be printed in full in the weekly hearing bulletin. The chairman of any senate committee may file notice of hearing on or before Wednesday noon of the second week prior to the week in which the public hearing is scheduled if he desires advance notice of the hearing to be posted.

SECTION 2. **Printing of engrossed senate rules.** Within one week from the adoption of this resolution the chief clerk, if at that time there are no other senate resolutions pending to change the senate rules which, in the judgment of the chief clerk, will probably be agreed to by the members of the senate so as to further change the senate rules, shall cause the printing of this resolution as adopted by the senate, and incorporating the entire text of the senate rules. The document so printed shall be deemed the engrossed copy of this resolution.
