To the Honorable, the Senate:

I am signing Senate Bill 123 into law. The bill relates to the preservation of the Wolf River as a scenic area and makes an appropriation.

Because Senate Bill 123 is an appropriation bill, I am exercising my authority to veto in part certain language to technically improve the bill. First, I am vetoing the language relating to the end of calendar year 1973. This is to permit additional appropriations in the event they are called for in the annual budget review. I have taken no position whether such additional appropriations are necessary, and I am merely providing that the budget bill will be the appropriate vehicle for such appropriations in the event they are justified.

Second, I am vetoing the language relating to termination at the end of the first, second or third year of the agreement. This language is extraneous to the bill in its present form.

Finally, I am vetoing the letter "g" so that the language previously contained therein now follows in "f". This is necessary because of a cross reference found in 20.370 (1) (em).
