### INTRODUCTION OF RESOLUTIONS

#### **Senate Resolution 36**

Requesting an opinion of the attorney general outlining guidelines for obtaining approval of the senate and assembly committees on natural resources for condemnation of lands and waters for state park purposes by the department of natural resources.

Resolved by the senate, That the attorney general is requested to issue an opinion outlining guidelines for implementing the provisions of s. 27.01 (2) (a) of the statutes, relating to obtaining approval of the senate and assembly committees on natural resources for condemnation of lands and waters for state park purposes by the department of natural resources.
