Whereas, questions have been raised as to whether such extended functions 'are in violation of state statutes and as to whether the commission has become an unnecessary and illegal layer of government; and

Whereas, the commission did in fact compete successfully against a state agency for federal funds which has resulted in duplication of a state program; now, therefore, be it

Resolved by the senate, That the attorney general is requested to provide an opinion clearly delineating the functions of community relations -- social development commissions as authorized by section 66.433 of the statutes; and, be it further

Resolved, That such opinion specifically provide an answer to the question: "Does the commission have the authority to operate programs and/or provide direct services to individual citizens?".
