## INTRODUCTION OF RESOLUTIONS

#### Senate Resolution 42

To create senate rule 94, relating to issuing senate certificates of commendation, congratulation or condolence.

### Analysis by the Legislative Reference Bureau

The ordinary vehicle for an expression of opinion by the legislature is a resolution or joint resolution, subject to debate and amendment in one or both houses. To express the feelings of the legislature with reference to a person, organization or event, the Wisconsin legislature follows a simplified procedure under joint rule 26 whereby each house, or both houses jointly, can issue certificates of commendation, congratulation or condolence. The certificates are issued in the text proposed by the sponsor after approval by one or both houses.

This proposal would, for the senate, further simplify issuance of certificates by allowing citations on behalf of the senate to be issued whether the senate is in session or in recess, and whether or not the individual certificate was formally approved by the senate. All certificates under the new senate rule would be typed by the senate chief clerk's office.

Resolved by the senate, That senate rule 94 is created to read:

Senate Rule 94. Citations on behalf of the senate. With prior approval by the committee on senate organization any member of the senate may, whether the senate is then in actual session or in recess and without formal approval by vote of the senate, issue a citation on behalf of the senate to a particular person or organization or to commemorate a particular occasion as specified in the citation.

- (1) Citations may be used in place of resolutions for commendations, congratulations and condolences of persons or organizations or to give recognition to unusual and important events, except the use of citations shall not be abused. The committee on senate organization may more specifically interpret this paragraph.
- (2) If desired by the issuing member, a citation on behalf of the senate may be coauthored by one or more other members or cosponsored by one or more representatives to the assembly, but in that case the proposal for issuing the citation shall be signed by each of the coauthors or cosponsors.
- (3) Any citation on behalf of the senate shall be signed by the issuing senator and by either the lieutenant governor, or by the president pro tempore, or by the vice president. In addition, the issuing senator may invite one or more coauthors or cosponsors to sign the citation. A copy of the finished citation shall be provided to the issuing senator, and another copy thereof shall be filed in the legislative reference bureau.
- (4) All citations on behalf of the senate shall be typed by employes assigned to the chief clerk, shall be prepared on an artistic form, approved by the senate organization committee, suitable for framing, and shall be in substantially the following form:

## Senate Resolution 43

To create senate rule 35 (3), relating to examining the appropriateness of certificates proposed to be issued under joint rule 26

## Analysis by the Legislative Reference Bureau

Joint rule 26 (6) and (8) specifies, as follows, when certificates may appropriately be issued by the legislature:

Joint rule 26 (6) Citations may be used in place of resolutions for commendations, congratulations and condolences of present or past legislators, state officials and public figures, or to give recognition to an important event.

(8) Citations may not be used for procedural matters nor in place of resolutions memorializing congress, but only when appropriate to express the feeling of the house or of the legislature with reference to a person or of an event.

The new senate rule proposed in this resolution would lay aside any proposal for a certificate under joint rule 26 so that the proposal can be examined by the committee on senate organization for its appropriateness under joint rule 26 (6) and (8). The committee will notify -- verbally -- the chief clerk of its determination, and the senate will then act on the proposal.

Resolved by the senate, That senate rule 35 (3) is created to read:

Senate rule 35 (3). Any proposal for a certificate under joint rule 26 shall, when received by the senate and whether originating in this house or in the assembly, be laid aside to allow time to the committee on senate organization to examine the proposal for its appropriateness under joint rule 26 (6) and (8). Upon approval by the committee on senate organization and verbal notification thereof to the chief clerk, such proposals shall then be presented to

the senate and acted upon as a whole. A committee report is not necessary before action may be taken.

# REPORT OF JOINT SURVEY COMMITTEE ON TAX EXEMPTIONS

## Appendix to Senate Bill 255

### Recommendation

All servicemen, whether on active or reserve duty, receive a \$1,000 exclusion of gross income under present state law. In addition, combat pay is wholly excluded from both federal and state income taxation.

Courts have generally ruled that individuals must be domiciled somewhere, that a serviceman must maintain a state of residence. In turn, the federal soldiers and sailors relief act, 50 U.S.C. Appendix secs. 501 ff., ensures servicemen serving outside their state of residence that no other state may tax their service income. Thus no serviceman undergoes double taxation.

Ordinarily, most military personnel take advantage of certain privileges accorded solely to residents. For instanct, they or their children frequently attend the univeristy as residents and they enjoy Wisconsin's veterans benefits on leaving the service. Furthermore, this bill would exempt servicemen's income even if their dependents were living in Wisconsin and enjoying the benefits of state residency.

From an equity standpoint, such a proposal would discriminate against all other citizens who are temporarily stationed outside of the state's boundaries. Federal congressmen, peace corps volunteers, foreign service officers, AID personnel and other civilian governmental and private employees are in the same circumstance as military personnel but would still pay state income taxes.

For these, reasons, this bill is undesirable as public policy.

Know you by these presents:

Whereas, March 17th is annually observed as a special day for Irishmen in Wisconsin and other corners of the world. As it is set aside in honor of the patron Saint of Ireland, St. Patrick, a man who would have fit well into the history of Wisconsin; and

Whereas, many citizens of this state can trace their ancestry, in varying degrees, back to Ireland while other state residents would like to on this day, be able to trace their ancestry back to Ireland

and boastfully declare that they too are Irish; now, therefore, The Members of the Wisconsin Legislature, on the motion of Senators Devitt, Murphy, Keppler, Johnson, Flynn, M. Swan, J. D.
