THE BOARD FINDS

1. *Irene Handschke*

Irene Handschke, Route 1, Fremont, Wisconsin, claims \$28.00 as the result of hitting her head on the corner of the door to the health screening bus when ascending the steps at Weyawega, Wisconsin, on September 7, 1973. She required three stitches to close the wound, and the claim is for medical services performed. The board concludes the claim should be paid on equitable principles.

2. *Baxter Richardson*

Baxter Richardson, 2206 West Laven Ave., Madison, Wisconsin, claims \$150.00 for a watch, tape recorder, and binoculars taken from his home on June 25, 1972. The items allegedly were taken by a foster child on runaway status. The claimant did not report the theft to police, and accordingly could not receive reimbursement under his insurance coverage. The child had been temporarily left in a shelter home not operated by the State of Wisconsin at the time of his runaway. The board concludes there is not evidence of negligence on the part of officers, agents or employees of the state, and concludes the claim is not one for which the state is legally liable, nor one which the state should assume and pay on equitable principles.

3. *Gerrit G. Haima*

Gerrit G. Haima, 626 Morse Street, Waupun, Wisconsin, claims \$109.50 for the loss of a watch, cash, and car expenses on June 11, 1973, at Winnebago State Camp when he was assaulted by an inmate while on duty as the night officer. The board finds the reasonable value of the wrist watch was \$45 instead of the \$90 claimed, and concludes the claim should be paid in the reduced amount of \$64.50 on equitable principles.

4. *Rick Proft, Walter Proft and Dan Meyer*

Rick Proft, Walter Proft and Dan Meyer, all of Merrill, Wisconsin, join in a claim for \$453.90 for the loss of a tuba and carrying case, microphone, microphone cord, towing charge, gas and oil, and other items on July 6, 1973, at Merrill and Green Bay, Wisconsin. The items were taken from a car by a runaway from Lincoln Boys' School. The board concludes there is not evidence of negligence on the part of officers, agents or employees of the state, and concludes the claim is not one for which the state is legally liable, nor one which the State should assume and pay on equitable principles.

5. *Walter L. Callison*

Walter L. Callison, 68 Burroughs Drive, Madison, Wisconsin, claims \$50.00 for auto damages allegedly caused by a "blow-up" on I-90 near Hy. 51 near Stoughton on June 10, 1973. The Department of Transportation found no evidence of a highway blow up in that area on or near that date, and even if such evidence were present, it has been the consistent position of this board not to honor claims arising from highway "blow ups". The board concludes there is no evidence of negligence on the part of officers, agents or employees of the state, and concludes the claim if not one for which the state is legally liable, nor one which the state should assume and pay on equitable principles.

6. *Robert Svetlik*

Robert Svetlik, Route 4, Minawa Beach, Fond du Lac, Wisconsin, claims \$55.72 for damages to his auto on July 11, 12 and 13 near Highway 151 north of Fond du Lac. The investigation of the Department of Transportation disclosed that the damage was done on a county trunk highway, and consequently the board finds the claim is not one for which the state is legally liable, nor one which the state should assume and pay on equitable principles.

7. *Jerome W. Koenig*

Jerome W. Koenig, 126 King St., Neenah, Wisconsin, claims \$74.80 for the loss of a watch, repair to a wedding ring, medication, and replacement of clothing when the cycle he was driving while on duty as a trouper on Highway 76 on July 4, 1973, became defective and threw him. The board concludes the reasonable value of the items was \$55.00, and concludes the claim in the reduced amount of \$55.00 should be paid on equitable principles.

8. *Mrs. William L. Engnath*

Mrs. William L. Engnath, 3525 W. Verona Ct., Milwaukee, Wisconsin, claims \$257.40 for damages to her car caused by a brake shoe which had dropped from a truck on August 3, 1973, three miles South of Camp Douglas in Juneau County. There is no evidence of negligence on the part of officers, agents or employees of the state, and the board concludes the claim is not one for which the state is legally liable, nor one which the state should assume and pay on equitable principles.

9. *Dorothy L. Wiemer*

Dorothy L. Wiemer, 2363 N. 61st St., Wauwatosa, Wisconsin, claims \$30.97 arising from a fall at State Fair Park on August 14, 1973. The accident was reported to the first Aid Station at the

Park. Claimant has recovered \$16.00 from her insurance carrier, and the board concludes the balance of the claim in the amount of \$14.97 should be paid on equitable principles.

10. *Bradford's Piano and Organs, Inc.*

Bradford's Piano and Organs, Inc., 11550 W. North Ave., Milwaukee, Wisconsin, claims \$150.25 for damages to its organs while on display at State Fair Park on August 12, 1973, when a sewer backed up and caused flooding of their rented display space. The board concludes the claim should be paid on equitable principles.

11. *Frank S. Buelow*

Frank S. Buelow, 2972 S. Tenth St., Milwaukee, Wisconsin, claims \$2,629.85 for damages when he fell on the steps of the Wisconsin Employment Office at 2778 South 35th St., Milwaukee, Wisconsin. The building is leased by the state from a private party. The fall occurred in a common area of the building where the steps had been freshly painted on one side by the owner and may not have completely dried. There is insufficient evidence of negligence on the part of officers, agents or employees of the state, and the board concludes the claim is not one for which the state is legally liable, nor one which the state should assume and pay on equitable principles.

12. *Mariellen Janke*

Mariellen Janke, 3627 S. Dayfield Ave., Milwaukee, Wisconsin, claims \$5,045 for damages from a fall of three feet on September 11, 1971, into a manhole located on property near the University of Wisconsin at the 1300 block of University Ave. Claimant was reimbursed for her medical expenses of \$45 by her insurance carrier, and claims \$5,000 for pain and suffering. The manhole does not belong to the University of Wisconsin but to the City of Madison. There is insufficient evidence of negligence on the part of officers, agents and employees of the state, and the board concludes the claim is not one for which the state is legally liable, nor one which the state should assume and pay on equitable principles.

13. *Hildegard Palmiter (Estate of Floyd L. Palmiter)*

Hildegard Palmiter, Route 3, Edgerton, Wisconsin, claims \$123.92 on behalf of the Estate of Floyd L. Palmiter for overpayment of inheritance taxes on January 10, 1973. Since the county's share of the overpayment is \$7.33, the board concludes the balance of the claim in the amount of \$116.59 should be paid by the state on equitable principles.

14. *Estate of Ervin Kaun*

Russell Kaun, Executor of the Estate of Ervin Kaun, 10561 W. Forest Home Ave., Hales Corners, Wisconsin, claims \$903.54 plus interest for overpayment of inheritance taxes. The board finds the proper amount of overpayment was only \$679.74 less \$39.27 for the county's share, and concludes the net amount of \$640.47 should be paid by the state on equitable principles.

15. *D. Schuyler Davies*

D. Schuyler Davies, 323 E. Walworth Ave., Delavan, Wisconsin, claims \$56.85 for prepayment of 1965 real estate taxes on lands acquired by the State Conservation Department. The check for reimbursement was misplaced and voided after one year. The board concludes the claim should be paid on equitable principles.

16. *Eugene M. Embke*

Eugene M. Embke, Route 1, Etrick, Wisconsin, claims \$650 for a beef cow which drowned in a creek in Trempealeau County on June 20, 1973. The land where this occurred was purchased in 1972 by the Department of Natural Resources. Under an easement, the state is required to allow access for cattle to the creek in this area. Although fencing is incomplete, completion of the fencing would not prevent cattle from drowning in the creek near the 3 and 4 foot bank where this accident occurred. The board concludes there is insufficient evidence of negligence on the part of officers, agents or employees of the state, and that the claim is not one for which the state is legally liable nor one which the state should assume and pay on equitable principles.

17. *Richard R. Grage*

Richard R. Grage, Route 1, Highbridge, Wisconsin, claims \$1,170 for 39 lambs allegedly killed by coyotes in Town of Ashland in June and July, 1973. There is no connection between any activity of the state which should support the claim. Hunting and trapping of coyotes is allowed in or near the area. The bounty for coyotes in Ashland County is \$40.00. The board concludes the claim is not one for which the state should assume and pay on equitable principles.

18. *Little St. Germain Lake Improvement Assn.*

The Little St. Germain Lake Improvement Association, St. Germain, Wisconsin, requests \$1,148.44 for copper sulfate used for a program of spraying 931 acres of water for control of algae. The request for assistance is not consistent with the objectives of the claims board under s. 16.007, Wis. Stats. Although the association

is to be commended for its efforts, the board concludes that its request for funds cannot be recommended for payment.

19. *Douglas Hal Marconnet, by Edward F. Marconnet*

Edward F. Marconnet, 2361 N. 115th St., Wauwatosa, Wisconsin, on behalf on his minor son, Douglas Hal Marconnet, claims \$1,561.98 for damages arising from a fall at Tower Hill State Park on August 25, 1973. Claimant has recovered \$47.18 of the special damages of \$61.98 through his insurance carrier. The balance of the claim in the amount of \$1,500 is for pain and suffering. Claimant's son (born 1-29-71) fell on a trail to the parking lot from the Shot Tunnel area. He fell off the sidewalk at a point where the fence is 5 to 8 inches from the sidewalk. There is an immediate 3-foot drop, and the boy then rolled and slid another 25 feet. The boy was recovered by claimant's two older sons. The fence had been pulled back by others making a short cut along the trail. There is not evidence of permanent injury. The 2 1/2 year old boy had been left unattended because his father believed the fence would be adequate to protect him from falling. The board finds the father to have been negligent in some degree for not showing proper care for his son under the circumstances. There is insufficient evidence of negligence of state officers, agents, and employees, and the board concludes the claim is not one for which the state is legally liable, nor one which should be paid on equitable principles, except for the balance of medical expenses not covered by insurance in the amount of \$14.80.

20. *Mrs. Henry Hovey*

Mrs. Henry Hovey, 3 Beaumont Circle, Madison, Wisconsin, claims \$109.68 for auto damages on Swanson Road on July 23, 1973, when her car was hit by a lawnmower operated by the Department of Military Affairs. The board concludes the claim should be paid on equitable principles.

21. *Kenneth Young*

Kenneth Young, 6039 W. Fond du Lac Ave., Milwaukee, Wisconsin, claims \$109.28 for a damaged windshield caused by 13 BB shots fired near the Wisconsin National Guard rifle shooting booth at the State Fair Park on August 15, 1973. The board concludes the claim should be paid on equitable principles.

22. *Gary L. Fordham*

Gary L. Fordham, 123 Franklin Ave., Waukesha, Wisconsin, claims \$974 damages to his vehicle arising from an accident on June 30, 1973, on I-94 near the 124th St. overpass in Wauwatosa, Wisconsin. The claimant's car collided with a jeep driven by

Joseph Gunta who was in a military convoy returning to Milwaukee from Camp McCoy. Since there is dispute over the facts, and the claimant request that the matter be tried in Circuit Court, the board concludes the claim should be denied.

23. *Barbara Glawe, Special Admin., Estate of Philip Arnold, Deceased*

Barbara Glawe, Special Administrator, Estate of Philip Arnold, Deceased, submits a claim for \$200,000 for the purpose of having it turned down to enable the claimant to commence an action in Circuit Court under sec. 345.05, Wis. Stats. The claim arises out of an accident occurring on or about August 18, 1972, near Necedah on State Trunk Highway 21. Accordingly, the board denies the claim.
