- **453.02 Definitions.** As used in this chapter, unless the context requires otherwise:
- (1) "Examining board" means the veterinary examining board
- (2) "Veterinarian" means a practitioner of veterinary medicine who is duly licensed by the examining board.
- (3) "Animal" means any animal except a human being.
- (4) "Compensation" means any gift, reward, bonus, fee, money, credit or other thing of value, and any promise thereof
- (5) "License" means a license to practice veterinary medicine issued by the examining board.
- (6) To "practice veterinary medicine" means to examine into the fact or cause of animal health, disease or physical condition, or to treat, operate, prescribe or advise for the same, or to undertake, offer, advertise, announce, or hold out in any manner to do any of said acts, for compensation, direct or indirect, or in the expectation thereof.
- **453.04 Violations.** The chairman of the examining board shall institute actions for violations of this chapter. The district attorney of the county in which the offense is committed shall promptly prosecute any such violation upon being informed thereof, from any source.
- **453.05 Practice; penalties.** (1) No person shall practice veterinary medicine without a license from the examining board.
- (2) No license shall be required for artificial insemination, or for continuing the practice of pregnancy examinations of animals when such practice was engaged in prior to February 11, 1968 and for castrating, except for horses and dogs, or dehorning animals; for students at a veterinary college approved by the examining board, while working under the supervision of a licensed veterinarian; for employes of the state or federal government while engaged in their official duties; or for employes of an educational

- or research institution while engaged in teaching or research.
- (3) Any person violating this section shall for the first offense be fined not less than \$25 nor more than \$200, and for any 2nd offense within 3 years be fined not less than \$500 nor more than \$1,000
- (4) No person is prohibited by this section from castrating domestic animals, except horses and mules, from dehorning cattle, from treating sprains, cuts or other ordinary minor injuries; nor shall this section be construed to prohibit any person from treating diseases of domestic animals for compensation at any place which shall be 20 or more miles distant from the office or place of business of a practicing veterinarian.
- 453.06 Examination; license. (1) Licenses shall be issued only to persons who successfully pass an examination conducted by the examining board. At least one examination shall be held annually. Examination fees as fixed by the examining board shall not exceed \$50, payable in advance and not returnable. An applicant for a new license shall be at least 18 years of age and a graduate of a veterinary college which has been approved by the examining board. Persons who qualify for examination may be granted temporary permits to engage in the practice of veterinary medicine until the next examination conducted by the examining board. Veterinarians holding an existing license shall not be required to take any examination for renewal of their license. The examining board may grant a license, without any examination, to any person who holds a veterinarian's license issued by another state or country, if the license requirements in such state or country are substantially equivalent to those in this state and if such state or country recognizes licenses issued under this chapter. In case of failure at any examination, the applicant shall have the privilege of taking subsequent examinations, upon the payment of another fee for each examination, at any meeting of the examining board.

453.06 VETERINARY EXAMINING BOARD

(2) Licenses shall expire on December 31 of each year but may be renewed annually. The examining board shall charge a fee, not to exceed \$25, for each license or renewal thereof.

453.07 Deny, suspend or revoke licenses. The examining board may by order deny, suspend or revoke any license if the applicant or licensee is not qualified, has violated this chapter or a rule of the examining board, or has misrepresented or intentionally failed to disclose a material fact in making any application or report to the examining board. The department shall serve written notice of any such action by personal delivery or mailing to the applicant or licensee. The applicant or licensee may file a written demand for hearing by the examining board within 20 days after service of the department's notice; thereupon the action of the examining board shall be stayed pending hearing and service of its decision. 453.08 Injunction. In addition to any other remedies, the several district attorneys are authorized to bring action in the name of the state to enjoin violations of this chapter or the rules of the examining board.

453.09 Transitional clause. (1) This chapter shall take effect on July 1, 1961

- (2) Veterinary licenses issued under s. 95.52, 1959 statutes, shall be valid as licenses under this chapter subject to renewal as herein provided.
- (3) All rules and orders of the board under s. 95.54 in force prior to July 1, 1961, shall remain in force under this chapter until modified or rescinded.
- (4) All matters pending before the board under the former chapter shall be completed by the board under this chapter
