Dear Mr. Melvin:

The above Resolution requests the Attorney General to investigate the statewide activities of an organization known as the National Social White People's Party to determine whether any of that organization's activities may violate state law and, further, to prosecute or assist in the prosecution, of any violations that may be discovered. The Resolution also requests the Attorney General to submit a report on the results of his investigation.

## JOURNAL OF THE ASSEMBLY [March 3, 1976]

The purpose of this letter is to advise that an investigation has not been conducted because the Resolution did not refer to any specific matters which might appropriately be investigated by this office. As a matter of policy, we do not conduct investigations without specific matters upon which to focus. I am sure you can understand that generalized inquiries, with the potential they hold for abuse, are best avoided.

In view of the foregoing there is no formal report to be made at this time in response to the Resolution. However, we are prepared to be of assistance to the legislature in any specific investigative matter that may be felt to warrant our attention.
