#### JOINT SURVEY COMMITTEE ON TAX EXEMPTIONS

Public Policy Involved

#### Assembly Bill 1196

This bill is not desirable as public policy. It would be unfair to grant property tax exemptions to this selected type of handicapped person, while many other types of handicapped persons would not receive such benefits. Also, quadriplegics with low incomes who own or rent a home may be eligible for tax relief up to the maximum of \$428 through the Homestead Credit Program. In addition, the bill provides tax benefits without basing them on persons' financial need.

Assembly substitute amendment 1 to Assembly Bill 1200

This bill is not desirable as public policy. Although it serves a good public purpose to construct or renovate buildings in such a manner to remove barriers for handicapped persons, it would be unfair to provide special tax benefits for these types of renovations, while other types of renovations that serve a worthwhile purpose do not qualify for such benefits. There could also be administrative problems in determining what costs could be deducted under this bill.

#### Assembly Bill 1212

This bill is not desirable as public policy. It would grant special tax benefits to only selected businesses and property in areas exceeding an arbitrary population size. It would also be difficult to properly administer this bill because of the definitional problems.

#### Assembly Bill 1261

This bill is not desirable as public policy. Although, it would provide a tax exemption to organizations who provide worthwhile services, there are numerous other organizations who also provide worthwhile services but who would not receive this tax exemption. Since the term "aged" is not defined, there also could be administrative problems in determining who qualifies for the exemption.

## Assembly Bill 1270

This bill is not desirable as public policy. Although the bill is unclear as to whether the income taxes would be required to replace real property taxes on a dollar for dollar basis, a result of such an offset would primarily benefit property owners. Those persons who do not own any real property in such a local unit of government would receive little, if any, benefit from the income tax.

The bill also does not provide how the local unit of government would assess and levy a tax on income. There could be numerous administrative and taxpayer problems without a uniform method of taxation among local units of government.
