JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

Assembly Bill 1396

The Joint Survey Committee on Retirement Systems finds that the final average salaries upon which benefits are calculated under the three state-administered retirement funds are being distorted or manipulated, and that such practice is significantly effecting benefits and costs. If allowed to continue, such manipulation can destroy the actuarial soundness, the cost structure, the legislative intent as to planning and goals for retirement, and the equity between various groups within the funds. Without correction, the employer costs of the three retirement funds will increase dramatically in the near future. The Committee finds that it is essential to the public interest that corrective action relative to such manipulation be taken at the nearest opportunity.

The Committee finds that Assembly Bill 1396 would correct such manipulation. The Committee recommends the adoption of an amendment to the bill which would strike (a) on lines 12 and 13 of page 1, and that the following paragraphs be renumbered accordingly. With this specific amendment, the Committee strongly recommends passage of Assembly Bill 1396 during the current legislative session.
