INTRODUCTION AND REFERENCE OF RESOLUTIONS

Analysis by the Legislative Reference Bureau

For the duration of any session of the assembly (including 30 minutes before and after each session), existing assembly rule 10 prohibits the presence of any person registered as a lobbyist on that portion of the floor of the assembly chamber reserved to members. This amendment similarly restricts lobbyist presence in the west lobby of the assembly chamber and in the assembly parlor.

Resolved by the assembly, That:

Assembly rule 10 (intro.) is amended to read:

Assembly Rule 10. (intro.) ~~Persons of the following classes~~ During a session and for one-half hour before and immediately after any session only the persons enumerated in subs. (1) to (4), and no others, shall be admitted to that portion of the floor of the assembly chamber reserved to members during a session and for one-half hour before and immediately after any session, to the west lobby of the assembly chamber or to the assembly parlor. However, none of the following listed persons enumerated in subs. (1) to (4) shall have the privilege of the floor assembly chamber and adjoining areas referred to if registered as a lobbyist or directly or indirectly engaged in defeating or promoting any legislation.
