**JOINT SURVEY COMMITTEE ON TAX EXEMPTIONS**

**Public Policy Involved**

**Assembly substitute amendment 1 to Assembly Bill 1082**

To the extent that the provision prohibiting expenditure of public moneys and the levying of special assessments within districts would encourage the preservation of agricultural and conservancy lands, it is good public policy.

**Committee of Conference Report on Senate Bill 755**

1. Updating the reference in the Wisconsin law to the December 31, 1975 Internal Revenue Code for regulated investment companies, real estate investment trusts and insurance companies is desirable in that it brings them into closer conformity with the federal income tax provisions.

2. It is desirable to update the reference in the Wisconsin income tax law to the December 31, 1975 Internal Revenue Code in regard to determining federal adjusted gross income and itemized deductions. This will permit individuals to include federal tax laws enacted in 1975 in computing their income for 1976 and thereafter. The Wisconsin standard deduction and low income allowance are not affected by this provision.

3. This provision is desirable in that it clarifies that a Wisconsin state legislator's tax home is within the district from which he or she was elected and therefore, per diem payments they receive are not taxable if they are used for food, lodging or other living expenses while the legislator is away from his tax home and at the state capitol.

4. Under present law, income from business or property located in Wisconsin is taxable to nonresidents. However, if such income is received via a revokable trust, it is not taxable to a nonresident. This provision is desirable in that it would treat all nonresidents on a similar basis, in that income from business or property located in Wisconsin would be taxable, regardless of whether received with or without a revokable trust.

5. Since corporations other than insurance companies are no longer allowed a deduction for federal taxes, (as a result of Chapter 39, Laws, of 1975) it is also desirable to repeal the deduction for insurance companies.

6. It is desirable not to allow a business expense deduction to private corporations for expenditures on public officials, even though such expenditures may be legal. They give the appearance of impropriety and result in a loss of public confidence and respect for public officials.

7. To the extent that certain holding companies lack flexibility in transferring funds among their regulated subsidiaries, it is desirable to exempt dividends received by the holding company from such subsidiaries.

8. Since certain nonprofit insurance service plans are required to be incorporated for insurance regulation purposes, it is desirable to permit net business losses incurred prior to incorporation to be considered as a net business loss of the successor corporation.

9. Since other mandatory service charges that are part of the sale of tangible personal property are subject to the sales tax, it is also desirable that mandatory tips collected by country clubs, etc., are taxable.

10. Extending the time period for allowing contributions to Keogh retirement plans for state income tax purposes is desirable in that it treats all Keogh plans in the same manner.

11. The provision denying a corporate deduction for certain interest paid for the purpose of acquiring its own stock eliminates

some uncertainty in this area. The apportionment provisions produce more equitable results in corporate taxation than under current law. Since depreciation on property is deductible in determining business income, the gain or loss on the sale of such property should also be considered in determining business income. For these reasons, the provisions are desirable public policy.

12. The M & E exemption provision for manufacturers of optical equipment is desirable public policy because it conforms the tax treatment of such operations to the tax treatment of other manufacturing processes.

13. To the extent that it is in the interest of the public to ensure consistent treatment under the law of watercraft and to the extent that this provision achieves this goal, it is desirable public policy.

#### Assembly Bill 1231

This bill is not desirable as public policy. The bill does not contain a definition of "senior citizens" so it will be unclear as to which groups the bill should apply.

In addition, the present Wisconsin law in s. 77.54 (9a) provides a sales and use tax exemption for purchases of tangible personal property and services by nonprofit religious, charitable, educational and scientific organizations. This tax exemption provision is very similar to the federal income tax exemption language in Sec. 501 (c) (3) of the Internal Revenue Code. The Internal Revenue Code -- Sec. 501 (c) (4), (5) and (6) -- also provides income tax exemptions for certain civic leagues, labor, agricultural, horticultural organizations, chambers of commerce, garden clubs and other similar organizations. However, their unrelated business income may be subject to income tax. It would not be desirable to exempt from the sales and use tax sales by senior citizens' organizations -- departing from the federal language -- while other organizations (such as civic leagues and labor organizations) which may have a worthwhile purpose would not qualify for such exempt status.
