The plan should identify major transportation collectors and corridors, open space areas and population density centers. The master plan should not consider existing highways, streets and buildings, except major complexes or high density centers and natural geographic features. The legislature hopes the plan will become the basis of long-term urban redevelopment for this area of the state; and, be it further

Resolved, That the Southeast Regional Planning Commission report its findings to the legislature when it convenes in January 1977.

Dear Senator Risser and Speaker Anderson:

You have raised several questions concerning whether state legislation dealing with state and federal programs for assistance for railroad freight under the Railroad Revitalization Act, would be subject to question under Art. VIII, secs. 7 and 10, Wis. Const. You also inquire whether the presently proposed resubmittal of the previously abortive "transportation facilities" amendment would necessarily obviate such questions.

In your letter raising the above questions, you request that I consider the final general floorperiod of the 1975 Legislature which expires today. On the basis of the present time constraints and lack of actual statutory proposals, I am unable to provide a meaningful and carefully considered response to your inquiry at this time.
