### REPORT OF JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

#### Appendix to **Senate Bill 192**

#### Recommendation

There can be little doubt that the 14 day period between the effective date and cut-off date of Chapter 288, Laws of 1973, was insufficient for many or most of the eligible WRF participants to become aware of and to comply with the provisions of this act. Therefore, assuming that the legislature has already determined by enactment that the provisions of Chapter 288 are proper, it presumably should then permit sufficient time for participants to comply with those provisions.

This committee finds that Chapter 288, Laws of 1973 provided insufficient time for participants to comply with its provisions. 1975 Senate Bill 192 would provide an additional 90 days for participants to so comply, and the committee recommends passage of this bill.

**Appendix to Senate Bill 173**

**Recommendation**

Senate Bill 173 would grant retroactive service credit (up to a maximum of 6 months) to actively employed WRF participants who served a qualifying period before the change in WRF law became effective January 1, 1973. This bill would place such participants in the same relative position as those hired after 1/1/73 with regard to the amount of service credit which can be earned over a given working career. If 30 creditable service years is construed as a normal working career, participants who served a qualifying period must presently work 30 1/2 years to achieve this objective while newly hired participants need work only 30 years. Hence, Senate Bill 173 would provide greater equity in relation to service credit provisions for currently active participants.

It is the opinion of this Committee that Senate Bill 173 represents good public policy. Therefore, the committee recommends that the bill be enacted.

Appendix to **Senate Bill 132** and senate substitute amendment 1 thereto

**Recommendation**

Senate Bill 132 would provide that all supplemental salaries paid to circuit court reporters pursuant to S. 252.19 shall be subject to provisions of WRF law. As such, this bill would adversely affect court reporters of the 2d circuit whose supplemental salaries may

already be subject to a local retirement system. Senate substitute amendment 1 to Senate Bill 132 provides the same WRF coverage but with an exception for supplementary salaries that are now subject to a retirement system. The Joint Survey Committee on Retirement Systems, therefore, recommends the adoption of senate substitute amendment 1 to Senate Bill 132.

The committee finds that circuit court reporters receiving supplemental salaries are not treated in the same manner for retirement purposes as other judicial personnel receiving supplemental payments. The committee therefore recommends passage of Senate Bill 132 as amended by senate substitute amendment 1.
