#### Appendix to Senate Bill 388

#### Public Policy Involved

To the extent that this bill provides clarification and uniformity for certain parts of the inheritance and gift tax laws relating to exemptions, it is desirable as public policy.

Since some estates do not involve the courts, and therefore debts are not always presented to the court for approval, it is desirable to eliminate the "allowed by the court" provision in Section 2.
