Recommendation

This bill represents an equitable and reasonable "final disposition" of the local police and fire funds which were closed to new members in 1948. The bill would provide rough equality in benefits for the remaining active members of the local funds with those provided by the WRF. The bill would continue the legislative policy of merging and consolidating retirement plans and providing uniformity in retirement rights and obligations. This Committee finds that Senate Bill 240 is in the public interest and recommends its passage, but with the amendment as suggested in this report.
