**Recommendation**

**This bill is not desirable as public policy for it would exempt admissions to one specific group, while other groups would have to pay sales tax on admissions to similar sporting events or other entertainment.**

**Appendix to Senate Bill 400, senate substitute amendment 1**

**Recommendation**

**Present law provides that packaging and shipping materials are exempt if they are used by the purchaser to transfer merchandise to his customer. Packaging and shipping materials such as boxes are generally used by the mover to ship a customer's household goods from one location to another (rather than transfer the movers' merchandise to the customer); therefore, such packaging and shipping materials are taxable to the mover. It would be undesirable as public policy to provide a specific exemption for such materials to a mover or transfer company, while other persons using such materials for similar or other purposes may have to pay the sales and use tax.**
