Dear Governor Lucey:

re: Barbers Examining Board, Cosmetology Examining Board, and Funeral Directors and Embalmers Examining Board.

Chapter 39, Laws of 1975, the budget bill, appoints all former members of the Barbers Examining Council, Cosmetology Examining Council, and the Funeral Directors and Embalmers Examining Council to the newly created Boards, respectively. In my opinion, these legislative appointments arguably are constitutionally permissible. However, it also can be argued that, while the legislature can establish these boards and provide for the manner of choosing their members, only you have constitutional authority to make specific appointments to these positions.

The constitutional issue can best be resolved by a decision of the state supreme court, but it is reasonable to estimate that presentation of the issue and determination by the court will take at least a year.

At least one of these boards currently desires to act on a matter involved in a contested case. I am also informed that one or more of these boards desire to promulgate rules within the purview of their jurisdiction. The status of the legislative appointees on the boards is therefore a matter of concern, since all actions taken by these boards before a decision by the court as to the legality of the appointment of their members would be legally suspect.

I am informed that you have indicated your willingness to appoint by your authority those members already appointed by the legislature. In keeping with the normal procedure, these gubernatorial appointments will be submitted to the senate for confirmation.

It is my opinion that the gubernatorial appointment of legislatively appointed board members is legally permissible. This procedure should remove any doubt concerning the legality of these boards and their actions.

If the legislature does not have the power to make the appointments, then your appointments, with subsequent senate approval, would be legally valid. On the other hand, if the legislative appointments are valid, your appointment of the board members is a useless act which has no effect on the legality of prior appointment by the legislature. In either event, a challenge to the membership of the boards or to any action taken by the boards would, in my opinion, be unsuccessful.
