BEFORE THE CLAIMS BOARD OF WISCONSIN

The Claims Board conducted hearings at the State Capitol Building, Madison, Wisconsin, on November 29, 1976, upon the following claims:

THE BOARD FINDS:

1. Wisconsin Gas Company

Claimant

The Wisconsin Gas Company claims \$2,162.90 for damages to underground utilities. On February 3, 1976, a state crew was digging a hole for a "no parking" sign on Hwy. 12 and 27 near Black River Falls. Although no request for location of the underground facilities was made by the state under sec. 182.0175, Stats., said statute is not applicable to the state. A regulatory statute of general application does not apply to the state unless the

state is explicitly included by appropriate language. See, 68 Wis. 2d 677. Also, sec. 86.16, Stats., requires utilities to obtain approval for installations, but no permit was obtained by the gas company for installation of gas lines at this location. The Board concludes the claim is not one for which the state is legally liable, nor one which the state should assume and pay on equitable principles.

2. Norwood Health Center

Norwood Health Center, Wood County, Wisconsin, claims \$157,432.76 on equitable principles. Claimant concedes there is no legal basis for its claim. Because of a change in state accounting procedures under sec. 51.42, Stats., for Wisconsin mental hospitals, the claimant lost the benefits previously available under sec. 51.08, Stats., which would have permitted \$97,464.02 in county collections and \$59,968.74 in state collections. The legislature did not "grandfather" the claimant's situation into the new law. As a consequence the claimant legally could not be reimbursed for the undepreciated value of its old hospital which was condemned under sec. 46.17(3), Stats., on September 9, 1972. A new facility was constructed at a cost of \$2,995,000.00. The Board concludes that the claimant should be reimbursed for the \$59,968.74 which it could have collected from the state under the repealed law.

3. Vernon Schmid

Vernon Schmid, Sun Prairie, Wisconsin claims \$72.80 for damages to his car. On May 17, 1976, a patient at Mendota State Hospital damaged claimant's car, while parked on the grounds, by jumping on it. The Board concludes the claim should be paid on equitable principles.

4. Peter Pesh

Peter Pesh, Salem, Wisconsin, claims \$9.36 for damages to his car. On May 11, 1976, a resident of Southern Wisconsin Colony broke off claimant's radio antenna while his car was parked on the grounds. The Board concludes the claim should be paid on equitable principles.

5. James Ennis

James Ennis, Oakfield, Wisconsin, claims \$38.00 for the loss of his wedding ring. On July 26, 1975, claimant was stabbed by an inmate from the Winnebago Camp. Claimant is an officer at the camp, and the stabbing occurred during a struggle with the inmate who was attempting an escape. Claimant was operated on at Appleton Hosptial. It was necessary to cut his wedding ring before his wounded hands could be operated upon. The Board concludes

the claim should be paid on equitable principles. The claim is not covered by sec. 46.062, Stats.

6. Roberta Jordan

Roberta Jordan, Greenfield, Wisconsin, claims \$64.48 for damages to her car. On August 14, 1975, she was parked at the State Fair Park. She had been assured by the parking attendant that her car would not be "boxed in" for any length of time. However, claimant's car was "boxed in" for at least five hours, and when it became necessary for it to be moved some damage resulted from forcing its removal. The Board concludes the claim should be paid on equitable principles.

7. George Chia-Jen Wang

George Chia-Jen Wang, formerly of Madison, Wisconsin, claims \$8,164.00 for 1256 hours of personal services at \$6.50 per hour performed in July and August of 1971, and from September, 1972, to June, 1973, for the University of Wisconsin-Madison. According to information from Dean Mulvihill, Edward Kimsky and Robert Greene of the university staff, claimant has been paid in full for his services, and the Board so finds. The Board concludes the claim is not one for which the state is legally liable, nor one which the state should assume and pay on equitable principles.

8. Gustafson Oil Company

Gustafson Oil Company, Wichita, Kansas, claims \$575.03 for damage to one of its vehicles. On November 8, 1975, the vehicle hit a loose piece of steel on a state bridge west of Abbotsford on Highway 29. On November 7, a steel plate had been installed to temporarily cover a hole on the bridge which was being repaired. During the night bridge traffic loosened the bolts holding the plate in place, resulting in the damage to claimant's vehicle. The Board concludes the claim should be paid on equitable principles.

9. David Evans

David Evans, Rockford, Illinois, claims \$211.15 for damage to his boat. On June 13, 1976, after putting his boat in Lake Kegonsa, it hit rocks 30 feet from the boat dock. The presence of the rocks are part of the naturally occurring conditions of the lake, and was unknown to the Department of Natural Resources prior to the accident. Their presence was partly due to the lack of rainfall. There is no evidence of negligence on the part of employees, officers and agents of the state, and the Board concludes the claim is not one for which the state is legally liable nor one which the state should assume and pay on equitable principles.

THE BOARD CONCLUDES:

1. The claims of the following named claimants should be denied:

The Board recommends that payment of \$59,968.74 be made to the Norwood Health Center as reimbursement for the state's share of the undepreciated value of its old hospital, which would have been collectable from the state under the method of accounting used prior to the repeal of sec. 51.08, Stats., and the adoption of a new method under sec. 51.42, Stats., under ch. 90, Laws of 1973.
