Appendix to Senate Bill 130

Recommendation

Senate Bill 130 concerns the protective occupation participants of the Wisconsin Retirement Fund. For such participants the legislature has established age 55 as the normal retirement age and also a higher benefit formula so that they would not be penalized because of the earlier normal retirement age. However, many protective participants are staying on the job several years after the normal retirement age, and the formula then "overcompensates" for such participants. Senate Bill 130 provides for a proportional reduction in the formula factor applied to protective participants who continue in such employment beyond the normal retirement age. This provision would restore the intent of the legislature and, therefore, the Joint Survey Committee on Retirement Systems recommends passage of Senate Bill 130.
