**REPORT OF JOINT SURVEY COMMITTEE ON
TAX EXEMPTIONS**

**Appendix to Senate Bill 111,
senate substitute amendment 1**

Public Policy Involved

This bill would create uniform tax treatment for all metallic mining in Wisconsin. Currently, the type of treatment varies depending on the type of ore mined. Surface property and improvements, except for exempt machinery and equipment, would be subject to local property taxation like other manufacturers in the state. A new net proceeds tax would be imposed on the ore as it is extracted and current severance taxes would be eliminated. The rate structure would be progressive, with rates ranging from 0 percent to 20 percent. The bill would continue to subject metallic mining companies to the corporate franchise and income tax like all other corporations. It would, however, phase out the percentage of income depletion allowance over a ten year period but retain the option of a cost depletion allowance.

This bill is desirable as public policy.

BEFORE THE
CLAIMS BOARD OF WISCONSIN

The Claims Board conducted hearings at the State Capitol Building, Madison, Wisconsin, on May 9, 1977, upon the following claims:

Kenneth H. Simos in the amount of \$30,000 as compensation for wrongful imprisonment under sec. 285.05, Stats. Claimant appeared by his attorney, Mark A. Frankel, and the Department of Health and Social Services appeared by its attorney, David Whitcomb. No testimony was taken.

The claimant's conviction for a burglary committed on November 27, 1969, was affirmed by the Wisconsin Supreme Court on January 4, 1972. See *Simos v. State*, 53 Wis. 2d 493, 192 N.W.2d 877 (1972).

On April 5, 1973, the United States District Court for the Eastern District of Wisconsin entered its Decision and Order in the case of *Simos v. Gray*, 356 F. Supp. 265 (E.D. Wis. 1973), granting claimant's petition for a writ of habeas corpus. Part of the federal court's reasoning was that the state failed in its duty to disclose police reports which indicated, *inter alia*, that on the night of the offense the same witnesses who identified the claimant declined to view photographs on the grounds that they were sure they could not identify the persons observed on the night of the burglary, and that five days later a mistaken identification was made, when the trial turned on the reliability of the identification by such witnesses. Also, the claimant's female codefendant was acquitted after the suppressed evidence had been disclosed.

THE BOARD FINDS:

These foregoing events do not make it clear to the Board that the claimant was innocent beyond a reasonable doubt of the burglary, although they may raise some doubt as to his guilt. Similarly, the federal court's conclusion that a denial of due process demanded that the claimant be given a new trial is not evidence

that the claimant was innocent beyond a reasonable doubt of the burglary for which he suffered imprisonment, even though it may raise some doubt as to his guilt.

The Board finds that it is not clear beyond a reasonable doubt within the meaning of sec. 285.05, Stats., that claimant was innocent of the crime for which he suffered imprisonment, and denies the claim.

**BEFORE THE
CLAIMS BOARD OF WISCONSIN**

The Claims Board conducted hearings at the State Capitol Building, Madison, Wisconsin, on November 29, 1976 and May 9, 1977 upon the following claims:

1. Shawano County in the amount of \$241,738.52.
2. The County/Town of Menominee in the amount of \$5,575.76.

THE BOARD FINDS:

The claims are documented and have been audited, and the Board finds that the amounts involved were actually paid by claimants for expenses relating to the takeover of the Alexian Brothers Novitiate in Shawano County by the Menominee Warriors during the period of January 1, 1975, to February 3, 1975. Most of the expenses were for wages paid to extra local law enforcement personnel for the period of January 1, 1975, to

January 8, 1975, prior to the time that the Wisconsin National Guard exercised its jurisdiction over the area.

THE BOARD CONCLUDES:

A majority of the Board concludes that the situation was a matter of both statewide and local concern, and that the expenses involved should be shared equally at the state and local levels. (Roberts and Hubbard conclude the situation essentially was a matter of statewide concern, and that the Shawano County claim should be paid in full by the state.) All members of the Board agree that those involved performed their duties in a reasonable manner, and are to be commended for their efforts.

THE BOARD RECOMMENDS:

1. Payment of \$120,869.26 to Shawano County for 50% of its expenses related to the takeover of the Alexian Brothers Novitiate from January 1, 1975, to February 3, 1975.
2. Payment of \$2,787.88 to the County/Town of Menominee for 50% of its expenses related to the takeover of the Alexian Brothers Novitiate from January 1, 1975, to February 3, 1975.
