The question was: Shall the vetoed part of the bill, item VII-A, sections 25, 32d and 985d pass notwithstanding the objections of the Governor?

The ayes and noes were required and the vote was: ayes, 17; noes, 15; absent or not voting, 1; as follows:

Ayes -- Senators Bidwell, Chilsen, Cullen, Goyke, Harnisch, Keppler, Krueger, Lasee, McCallum, Morrison, Murphy, Peloquin, Petri, Sensenbrenner, Theno, Thompson and Van Sistine -- 17.

Noes -- Senators Adelman, Bablitch, Berger, Braun, Dorman, Flynn, Frank, Kleczka, McKenna, Lorge, Maurer, Offner, Parys, Radosevich and Risser -- 15.

Absent or not voting -- Senator Swan -- 1.

Less than two-thirds having voted in the affirmative, the senate refused to pass the vetoed part of the bill notwithstanding the objections of the Governor.

By request of Senator Bablitch, with unanimous consent, **Senate Joint Resolution 1** was withdrawn from the committee on Senate Organization and considered for action at this time.

Relating to the adjournment sine die of the June 1977 special session.

Read and adopted.

Upon motion of Senator Bablitch, the Senate adjourned pursuant to Senate Joint Resolution 1.
