Note: This is a correction of a typographical error which occurred in senate substitute amendment 5 to the bill. Senate substitute amendment 5 was used as the base document in the drafting of senate substitute amendment 6, which was passed by the senate. The mistake was therefore incorporated into engrossed Senate Bill 15. The affected portion of the engrossed bill was again used in the drafting of assembly substitute amendment 2, which was passed by the assembly and is the basis of the enrolled bill.
