Dear Mr. Schneider:

This is to inform you that the Joint Committee for Review of Administrative Rules (JCRAR) has begun keeping the committee's official records of legislation. Explanatory memorandum, analysis, internal committee communications with staff and staff with the committee, public information documents and various other pieces of information relating to committee rules' suspension bills and other committee bills which become law, will be available to members of the Legislature, their staff and the public.

We, as Cochairmen of the Committee, will be the custodians of those records and Douglas Johnson, the Committee's senior staff assistant, will be the Deputy Custodian. The records will be kept in the state capitol and in that place which we as Cochairmen will designate. For now, these official committee records will be located in Room 49 North of the State Capitol.

This action is being taken pursuant to our authority as Chairmen under the Senate and Assembly rules and the committee's authority under s. 13.45(7) and 13.56, Wis. Stats. The purpose of the action is to help "promote adequate and proper rules, statements of general policy and interpretations of statutes by agencies and an understanding upon the part of the public respecting such rules, statements and interpretations" (see s. 13.56(2), Wis. Stats).

In order that as many interested people as possible are aware of these records, would you please put this memo or its summary in the Journals of both houses.
