# State of Oklahoma 37th Legislature

A concurrent resolution criticizing any required conversion to a metric system; memorializing the Oklahoma congressional delegation to halt and abolish any required metric system conversion; and directing distribution.

Whereas, the Congress of the United States of America has debated for two hundred years on the question of whether to mandate a conversion to the metric system of weights and measures; and

Whereas, certain federal agencies feel it necessary to require conversion to a metric system; and

Whereas, a majority of the citizens of Oklahoma are not in favor of any conversion to the metric system; and

Whereas, the cost to convert to the metric system would be prohibitive to the public.

Now, therefore, be it resolved by the house of representatives of the 1st session of the 37th Oklahoma Legislature, the senate concurring therein:

Section 1. The Oklahoma Legislature does hereby memorialize the members of the Oklahoma Congressional Delegation to initiate efforts in the Congress to halt and abolish any required conversion to a metric system.

Section 2. Copies of this resolution shall be distributed to the President of the United States, to each member of the Oklahoma Congressional Delegation, to the United States Metric Board, to the Secretary of the Department of Commerce, and to the Legislatures of every state in the Union.

#### State of Wyoming 45th Legislature

A joint resolution to petition Congress to call a constitutional convention to amend the Constitution of the United States to limit the taxing and spending authority of the federal government.

Be it resolved by the legislature of the state of Wyoming, a majority of the members of each house, voting separately, concurring herein:

- Section 1. That the Congress of the United States call a convention of the several states for the specific and exclusive purpose of proposing an amendment to the Constitution of the United States of America, the amendment to provide in substance that taxes or expenditures by the federal government may not exceed an amount equal to the actual taxes or expenditures for the preceding fiscal year, computed on a per capita basis, increased by the percentage increase in the United States Consumer Price Index and the national population for the preceding fiscal year, and that this limitation may only be suspended upon proclamation of a national emergency by the President of the United States and concurrence therein by two-thirds of the members of each house of Congress, or to suppress insurrection or provide for the national defense;
- Section 2. That the legislatures of the several states comprising the United States join in petitioning Congress to call a constitutional convention for the exclusive purpose above stated;
- Section 3. That certified copies of this resolution be transmitted by the Secretary of State to the President of the United States, the President of the Senate and Speaker of the House of Representatives of the Congress of the United States, and to each member of the Wyoming Congressional Delegation; and
- Section 4. That copies of this joint resolution be transmitted by the Legislative Service Office to the Secretary of State and to the presiding officers of both Houses of the Legislature of each of the other States in the Union, with the request that it be circulated among leaders in the Executive and Legislative branches of the several State governments; and with the further request that each of the other States in the Union join in requiring the Congress of the United States to call a constitutional convention for the purpose of initiating a proposal to amend the Constitution of the United States in substantially the form proposed in this joint resolution.
