Subject: Two Additional Positions for Wetland Mapping

I have signed the minutes of Joint Finance Committee, dated March 29, 1979, and did not line veto item XB relative to the two additional GPR positions for wetland mapping activities.

Instead, because of my concern about adding positions in any form and opening up that pressure gate, I will via this memo direct the two Secretaries to further investigate within the next three weeks the method of achieving the goal involved here (i.e., wetland mapping for Wisconsin) by means other than two, full-time GPR positions. What I have in mind are the various units within the University system related to this activity and highly skilled and qualified senior students in this area. This kind of activity is going on on a project basis related to experience and classroom situations. It is also carried on under the supervision of highly qualified people; and is an activity in which the mapping results are graded by those faculty and a condition under which students work toward the best possible quality end product. I do not mean, of course, beginning students or students who are not qualified to do the task. I am talking about a project whereby students could be selected, could be paid in terms of student help, and, thus, support their education while gaining the ends involved. I still think this is a very real possibility that would "kill two birds with one stone". It would achieve the results for the state of Wisconsin and at the same time, improve the quality of education in this very area.

I hope it is understood by both Secretaries that if this cannot be determined as a feasible way to produce the results within the next 30

days, the positions should be filled and the project moved ahead for the next four years.

State of Indiana  
101st General Assembly

A Joint Resolution requesting the Congress to call a convention for the purpose of proposing an amendment to the Constitution of the United States to the effect that, in the absence of a national emergency, the total of all Federal appropriations made by the Congress for any fiscal year may not exceed the total of all estimated Federal revenues for that fiscal year.

Be it resolved by the General Assembly of the State of Indiana:

Section 1. The General Assembly of the State of Indiana makes application to the Congress of the United States for a convention to be called under Article V of the Constitution of the United States for the specific and exclusive purpose of proposing an amendment to the Constitution to the effect that, in the absence of a national emergency, the total of all Federal appropriations made by the Congress for any fiscal year may not exceed the total of all estimated Federal revenues for that fiscal year.

Section 2. The Secretary of the Senate is instructed to transmit a certified copy of this joint resolution to the President of the Senate of the Congress of the United States, the Speaker of the House of Representatives of the Congress of the United States, the presiding officer of each chamber of each state legislature in the United States, and each member of the Indiana congressional delegation.
