GOVERNOR'S VETO MESSAGE

March 27, 1980

To the Honorable Members of the Assembly:

I have vetoed **Assembly Bill 1241**.

I strongly believe there should be a way in which choice in judicial elections is assured even if a candidate dies before election. The permanent method established should be well thought out since we are dealing with state offices and officers whose decisions affect peoples lives substantially.

The manner in which Assembly Bill 1241 has been dealt with, however, does not reflect well on the legislative process. It has compromised, if not corrupted, a nonpartisan judicial election. It has established a questionable state public policy affecting members of an independent branch of government without public hearing, and with one person in mind. It has broken the time honored orderly consideration of bills by the Governor.

The issue of how vacancies should be filled requires careful consideration. Under the process in this bill, a sitting judge running unopposed who then dies in office would have a replacement named by the campaign committee, if there is one, which may be only one person. The person designated would then be elected, unopposed, for a six-year term. That could happen this year in 14 cases where sitting judges are running unopposed. Under an appointment by the Governor, the appointee must seek election, and be open to competition in the following spring election. This bill gives greater power to a personal campaign committee than the Governor has under law and actually reduces choice for voters under these circumstances.

The timing of this bill is especially troublesome. Ballots have been printed and were printed when this legislation was passed. If this bill were to become law, persons who have voted by absentee ballot, numbering in excess of 650, will have cast a different ballot from those voting at the polling place. I believe we should insure a uniform ballot for all voters.

Caught in the middle, as is usual when petty partisanship overwhelms state interests, are the people who believe in a nonpartisan judiciary, in choice in elections, in fair treatment for candidates, in the full franchise for every voter. This bill is not compatible with any of those principles. Therefore, I have vetoed it.

I have discussed the process of filling vacancies with the Attorney General and we both are willing to work with the Legislature to responsibly consider a reasoned statewide solution to the issue of insuring choice in such elections.
