Dear Friends:

Words come hard at a time like this. How do you sum up 20 years of a man's life and thank so many who meant so much to him in the scope of a single letter?

For 20 years, the legislature dominated Dad's life. From the early days, when he bunked with Bill Ward and Bob Barabe, through the turbulent Sixties, when he often battled popular opinion and the ravages of cancer and its treatment at the same time, to the testimonials at his retirement, when his usual glibness was overwhelmed by emotion, his life revolved around the Assembly. He reveled in the debates, proud that a farm boy with limited education could hold his own in the Big City. He cherished his legislative victories and accomplishments. He recognized the legislature as a forum of democracy, and while he was renowned for his sometime disregard of public opinion, he never forgot that he represented a constituency and was the voice of a people.

But mostly Dad enjoyed the people in the legislature and its halls. Dad liked people and hoped they liked him. His natural sympathy and compassion were strengthened by his 20 year battle with cancer, coinciding almost exactly with his legislative service. Sure, Dad took note of a person's politics, but his feeling and respect for people were never bounded by ideology or party line. When the legislature gave the testimonial for Dad in 1978, he was proud of the recognition of his skills and his services and accomplishments over the years. But the thing that brought tears to his eyes--that made him grip the podium, unable to speak--was the respect and the warmth and the affection that was not based on politics and didn't divide on party line.

For all this, we, Harvey Dueholm's family, who shared his legislative battles and triumphs, thank you, the Wisconsin legislators
