A Proclamation

I, Lee Sherman Dreyfus, Governor of the State of Wisconsin, pursuant to Section 11 of Article IV and Section 4 of Article V of the Constitution, do hereby amend the call for a Special Session of the Legislature, issued on the 22nd day of May, 1980 and amended on the 2nd day of June, 1980, as follows:

Add paragraph (9) to read,

Amend and create various provisions of the statutes and session laws for the purpose of providing effective dates, correcting errors, supplying omissions, correcting references and repelling unintended repeals (Revisor's Correction Bill).

In Testimony Whereof, I have hereunto set my hand and caused the Great Seal of the State of Wisconsin to be affixed. Done at the Capitol in the City of Madison this 19th day of June in the year of our Lord one thousand nine hundred and eighty.
