 - (1) Amend paragraph (1) to read,

Amending Section 8 of Article I of the Wisconsin Constitution, relating to revising the right to and conditions of bail and authorizing the Legislature, by law, to permit circuit courts to deny release on bail for a limited period to certain accused persons.

In testimony whereof, I have hereunto set my hand and caused the Great Seal of the State of Wisconsin to be affixed. Done at the Capitol in the City of Madison this 26th day of June in the year of

our Lord, one thousand nine hundred and eighty.
