CHIEF CLERK'S CORRECTION

Assembly Bill 293

In engrossing, the following adjustments were made in 1979 Assembly Bill 293:

Chapter 32, laws of 1979, renumbered chapters 245 to 247 of the statutes to be chapters 765 to 767 of the statutes. Accordingly, all references in the present bill to chapters 245 to 247 of the statutes or sections thereunder were in engrossing updated to be references to chapters 765 to 767 of the statutes and the sections thereunder, and all applicable cross-reference corrections in section 92 of chapter 32, laws of 1979, were in engrossing incorporated into the text of the present bill. In addition, the catalog of section numbers affected in the title of the present bill, all strings of cross-references to statute numbers, and the display of the text of the statute sections affected contained within this bill, have been resequenced in the ascending order of the statute numbers, and the bill sections numbered consecutively, in compliance with Joint Rule 52.

Because the text affected by assembly amendment 17 was deleted by the later adoption of assembly amendment 9, assembly amendment 17 was not given effect.

Assembly amendment 19, adopted after assembly amendment 7, inserted new text into s. 767.255 (intro.) as renumbered by chapter 32, laws of 1979. Accordingly, items 1 and 3 of assembly amendment

7 were not implemented, and item 4 of assembly amendment 7 was given effect only to the extent of deleting the underscored text (also deleted by assembly amendment 9) and restoring the stricken text. Item 5 of assembly amendment 7 was not given effect because the affected text was subsequently deleted by assembly amendment 9.

Assembly amendment 22, adopted after assembly amendment 7, inserted a new sub. (2r) into s. 765.255 as renumbered by chapter 32, laws of 1979. Accordingly, item 6 of assembly amendment 7 was not given effect but "(2m)" was replaced with "(2r)", and item 8 of assembly amendment 7 was implemented by inserting "767.255" before "(2r)".

Assembly amendment 9 was adopted after the assembly had adopted assembly amendment 23. Because assembly amendment 9, as the later action, deleted from the bill both proposed statute 247.255 (11c) and proposed statute 247.257, the limitation on those two statutes proposed in assembly amendment 23 was not incorporated into the engrossed bill.
