In response to the mandate contained in Section 2054(4) of the 1979-81 biennial budget act (Chapter 34, Laws of 1979), I am submitting the attached report to state government, "Preparing for a Decade of Enrollment Decline," along with a volume of background materials; and a summary statement given to the Board of Regents when the report was first introduced.

In order to meet the statutory report deadline of November 30, 1979, the Board unanimously adopted the following resolution at its November meeting:

That the Board of Regents approves in principle the major concepts and recommendations incorporated in the draft document, "Preparing for a Decade of Enrollment Decline," for forwarding as an information report to state government on November 30, 1979, subject to such further editing for clarity and accuracy as may be desirable on the basis of continued discussions with the institutions, and subject to final review of the document at the Regent meeting in December for introduction of any further changes that the Regents may direct and final approval of the document and its appendices.

Final Board action on the report will not occur until the December 14 meeting and it is possible that some changes may be made at that time. The final report will be sent to all legislators.

There is no need for me to emphasize the seriousness of the issues discussed within this report, or the seriousness with which we have approached them. I look forward to a productive dialogue.
