A Proclamation

I, Lee Sherman Dreyfus, Governor of the State of Wisconsin, pursuant to Section 11 of Article IV and Section 4 and Article V of the Constitution of Wisconsin, do hereby require the convening of a special session of the Legislature to take place at the Capitol in Madison on the 3rd day of June, A.D., 1980, at ten o'clock a.m., solely for the purpose of considering and acting upon the following specific pieces of legislative business, to-wit:

1. Amending Section 8 of Article I of the Wisconsin Constitution to authorize the Legislature by statute to permit circuit courts to deny release on bail for a limited period to certain accused persons.
2. Changing the departments of natural resources; veterans affairs; agriculture, trade and consumer protection to a cabinet form of government headed by secretaries appointed by the governor, changing the tenure of the secretary of regulation and licensing, changing the method of removal of state officers.
3. Reducing the term of appointment for the adjutant general and changing the tenure of the deputy adjutant general and the assistant adjutant general for air.
4. Eliminating the departments of local affairs and development and business development and creating a department of development.
5. Changing the laws relating to industrial revenue bonds and projects.

6. Creating a low and moderate income neighborhood reinvestment and home ownership program.

7. Amending the statutes relating to legal representation of indigents.

A Proclamation

I, Lee Sherman Dreyfus, Governor of the State of Wisconsin, pursuant to Section 11 of Article IV and Section 4 of Article V of the Constitution, do hereby amend the call for a Special Session of the Legislature, issued on the 22nd day of May, 1980 as follows:

1. Amend paragraph (5) to read, Relating to payments for a comparable replacement business or farm upon condemnation and industrial revenue bonds and projects.

2. Amend paragraph (6) to read, Relating to issuance of Wisconsin housing finance authority bonds and notes for, and providing, home ownership mortgage and housing rehabilitation loans.

3. Amend paragraph (4) to read, Eliminating the departments of business development and local affairs and development, creating the department of development and transferring certain agencies and functions.

4. Add paragraph (8) to read, Resolving conflicts between Chapter 331, Laws of 1979 and Chapter 300, Laws of 1979.
