The Labor and Industry Review Commission adopted Clearinghouse Rule 79-71 by Order of February 15, 1980. The Commission's rules have cleared the legislative review process

without action. The Commission is now withdrawing its rules without proceeding to publication by the Revisor of Statutes and filing with the Secretary of State, because of recently enacted legislative changes which substantially affect our procedures.
