Dear Senator Berger:

I understand that on June 3, Representatives Thompson, Radtke, and Goodrich sent Senator Harnisch and Representative Munts a letter in which they contend that the modifications to NR 115 (SCR80-86) requested by Representatives Munts and Senator Harnisch, and approved by the Natural Resources Board, are not procedurally correct. While I do not agree with their contention, in order to avoid any possibility of future conflict over the procedures used to promulgate NR 115, I have ordered the Department staff to withdraw the modifications. If there is no Committee action before the end of the 30-day review period, the Department will transmit to the Revisor of Statutes the original NR 115 as it was submitted to the Legislature on April 30, 1980.

JOURNAL OF THE SENATE

I will then request that the Natural Resources Board at its June meeting authorize a hearing on an amendment to NR 115 that will be the same as the proposed modifications. The Department will then submit that amendment to the Legislature this fall.

This procedure will not impact on the effectiveness of the rule, because no wetland maps will be available until late this year, so no counties will be developing new shoreland ordinances until 1981.
