A Proclamation

I, Lee Sherman Dreyfus, Governor of the State of Wisconsin, pursuant to Section 11 of Article IV and Section 4 of Article V of the Constitution, do hereby amend the call for a Special Session of the Legislature, issued on the 22nd day of May, 1980 and amended on the 2nd and 19th days of June, 1980, as follows:

Amend paragraph (1) to read,

Amend Section 8 of Article I of the Wisconsin Constitution, relating to revising the right to and conditions of bail and authorizing the Legislature, by law, to permit circuit courts to deny release on bail for a limited period to certain accused persons.
