Dear Senators:

This is to inform you that the report by the Department of Employment Relations on limited term employment as required by Section 2015 of Chapter 221, Laws of 1979 is in the Senate Chief Clerk's Office, 140 South.

The report is in three sections:

Section I: Description for each agency of the recurring and nonrecurring activities in the agency in which limited term employes are used and the full-time equivalent number of limited term employes in each activity.

Section II: Discussion of advantages and disadvantages of hiring permanent employes rather than limited term employes to perform these recurring activities.

Section III: Department of Employment Relations recommendations as to appropriate utilization of limited term employes.

Section 2015 requires that this report be distributed to state agencies, the Governor and the Legislature on or before November 1, 1980, and that each agency formally address the budgetary implications of the report's recommendations before the submittal of the 1981-83 biennial budget to the legislature.
