Gentlemen:

On Monday, October 20, 1980, it was brought to my attention that the Governor's veto of the legislative review process for the Energy Development and Demonstration Program (Wis. Stat. 16.956) had been overridden by the Wisconsin Legislature. The Division staff had been working under the assumption that legislative review of the proposal summaries was not required by law, but now realize that an oversight has been committed. I apologize for that oversight.

In response to this discovery, I have instigated the following actions:

1. Tentative grant recipients have been contacted by mailgram and advised of the present situation and the need for legislative review; a follow-up personal telephone call will be made on Tuesday, October 21, 1980;

2. I am advising you of my intent to comply with the letter of the law; and

3. As specified in the statutes, summaries of the proposals submitted and a list of recommended recipients will be forwarded to you by Friday, October 24, 1980, so that proper legislative review can proceed.

It is my intention to resolve this matter quickly to the satisfaction of and fairness to the parties involved. Expeditious handling of the

legislative review will be appreciated. I hope this error on our part does not inconvenience you seriously.
