STATE OF WISCONSIN CLAIMS BOARD

The State Claims Board conducted hearings at the State Capitol Building, Madison, Wisconsin on February 21, 1983, upon the following claims:

THE BOARD FINDS:

- 1. Wisconsin Telephone Company of Milwaukee, claims \$2,438.65 for damages to an underground cable located at Highway 83 in the Village of Chenequa, on June 24, 1982. The cable was damaged while the Department of Transportation was conducting soil The Department of Transportation boring tests. requested the Telephone Company to locate and mark their lines in the area where the borings would be conducted: however, the cable that was struck was not marked. Claimant alleges that the location of the damaged cable was obvious based on a telephone facility box in the area. The Board finds there has been no conclusive evidence showing that the damage was caused by negligence on the part of the Department of Transportation. The Board concludes this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 2. Pommerening Dodge, Inc. of Oshkosh, claims \$6,362.50 for damages incurred as the result of the sale of a 1979 Ford truck to Kenneth Mittelstaedt on November 8, 1980. In August, 1980, claimant traded a 1977 Dodge Ramcharger to Diversified Services, Inc. for a 1979 Claimant alleges the the Department of truck. Transportation failed to properly check the serial number of the truck when the title was presented for registration in the State of Wisconsin. The Wisconsin title was issued by the Department of Transportation after the title identification number was compared to the identification number on the truck door according to the guidelines of the National Auto Theft Bureau. March, 1981, FBI agents informed Mr. Mittelstaedt that the truck was stolen and would have to be confiscated and returned to the owner. Mr. Mittelstaedt requested reimbursement from claimant for the purchase price of the truck, which claimant paid. The Board concludes

there has been an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.

- 3. Thomas Hruza of Melrose, claims \$19,991.00 for loss of value of his 1982 turkey flock allegedly caused by an American bald eagle. Claimant alleges that this turkey flock was repeatedly attacked by the eagle between August 29 and September 3, 1982, causing the flock to seek protection in the woods away from their feed, disrupting normal feeding habits and consumption and causing the turkeys to pile on top of one another causing abrasions and wounds to a substantial portion of the flock. The American bald eagle is protected by federal and state law and therefore cannot be captured or killed by authorization of the Department of Natural Resources pursuant to s. 29.596, Stats. The National Wildlife Health Lab can provide technical assistance in situations like this, such as use of covered pens and various scare techniques. In the absence of any statutory provision enabling payment for damages caused by wild animals, the Board feels it cannot honor this claim. The Board concludes this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles. (Members Wilker and Davis Gordon dissenting)
- 4. James Dickert of Racine, claims \$832.40 for the amount of unpaid rent and attorney fees incurred to evict the tenant, Richard Wrobel, who was relocated from his former residence to claimant's property as the result of a street improvement program in the City of Racine in 1982. The state has a relocation assistance program which provides payment to a tenant who is being relocated to a comparable property if rent is increased. According to s. 32.19, Stats., Mr. Wrobel was paid \$5,652.00 plus \$500 for moving expenses. Claimant alleges that the state advised him the tenant was reliable, however, the Department of Transportation indicates that there are no quarantees made by the state when relocating subjects such as this. The Board concludes there is insufficient showing of negligence on the part of the state, its officers, agents, or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 5. David Lefeber of Fond du Lac, claims \$150.00 for damages to his automobile incurred on April 3, 1982, when a piece of metal blew off the roof of a hangar in the Wisconsin National Guard parking lot at Truax field, where claimant is employed on weekends. The metal landed on claimant's automobile causing damage to the vinyl roof and trim. Sworn statements were obtained from witnesses who observed the incident. The Board concludes this claim should be paid in the amount of \$145.55, the lower of the two estimates submitted, based on equitable principles. The Board further concludes, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Military Affairs appropriation s. 20.465(1)(a), Stats.

- 6. Elmer Radichel of Dale, claims \$129.83 for damages to his automobile while parked at Crestview at the Northern Wisconsin Center for the Developmentally Disabled on July 4, 1982. A resident of the Center threw herself against the automobile, denting it. The Board concludes the claim should be paid, based on equitable principles. The Board further concludes, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.435(2)(gk), Stats.
- 7. Merle Sheridan of Merrill, claims \$19.00 for replacement cost of his shirt which was damaged by a resident of the Lincoln Hills School, where claimant is employed. On August 19, 1982, claimant was escorting a student to her room when she became upset and grabbed claimant's shirt, tearing a piece of material out of it. The Board concludes the claim should be paid in the reduced amount of \$15, based on equitable principles. The Board further concludes, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation 10.435(3)(hm), Stats.
- 8. Elizabeth Zachowski of New Lisbon, claims \$93.45 for damages to her automobile incurred on September 18, 1982, when an unattended food cart rolled off the curb and hit claimant's car in the left front fender while the automobile was parked in Parkview parking lot at the Northern Wisconsin Center. The Board concludes the claim should be paid, based on equitable principles. The Board further concludes, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.435(2)(gk), Stats.
- 9. Loretta Lane of Twin Lakes, claims \$229.88 for damages to her automobile while parked at the Southern Wisconsin Center parking lot on September 29, 1982. A resident of the Center ran into claimant's automobile on the drivers side front fender with his bicycle, causing dents and scratches. All but \$100 of the damages were apid by claimant's insurance carrier. The Board concludes the unpaid claim in the amount of \$100 should be paid, based on equitable principles. The Board further concludes, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.435(2)(gk), Stats.
- 10. Alfred Hunsicker of Sun Prairie, claims \$50.00 as the amount to repair his suit pants which were ripped on the sharp edge of a chair at the Waupun Correctional Institution on July 17, 1980, when he was attending a work-related program on grievance handling and corrective discipline procedures. The Board concludes the claim should be paid, based on equitable principles. The Board further concludes, under authority of s.16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.435(3)(a), Stats.
- 11. Loretta Langlois of Madison, claims \$61.00 for damages to her eyeglasses which occurred on August 27, 1982, when she was trying to unjam a stapler and it

suddenly loosened, hitting her glasses. Claimant is employed by the Department of Health and Social Services at the Wilson Street State Office Building, where the damage occurred. The Board finds there is no showing of negligence on the part of the state, its officers, agents, or employes and this claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
