State of Wisconsin Joint Survey Committee on Debt Management April 11, 1983

To the Honorable the Senate

The Joint Survey Committee on Debt Management hereby submits a Report on 1983 Senate Bill 83 (Biennial Budget Bill). This Report describes the provisions contained in the bill, as introduced, that relate to state debt and to revenue obligations. However, the Report does not contain any statements regarding the bill's (a) fiscal effect on state and local government, (b) effect upon state and local governments' ability to issue debt and revenue obligations, (c) appropriateness in relation to state and local government debt policy, and (d) desirability as a matter of public policy.

The Joint Survey Committee on Debt Management is required by s. 13.093 (2) (b), Stats., to prepare a report on the budget bill within 60 days of introduction. However, the members of the Committee feel that it is inappropriate to attempt to prepare a report on the appropriateness and desirability of the proposal, as introduced, since the Legislature will be considering a substitute version recommended by the joint committee on Finance. This version may contain substantially different borrowing-related provisions than the original bill.

It has come to our attention that the Wisconsin Department of Development, in conjunction with the Housing Finance Authority, will be submitting a proposal for an additional \$125 million in borrowing for economic development. In addition, the Housing Finance Authority may be requesting additional borrowing for housing loans. The Wisconsin Health Facilities authority will be requesting additional borrowing authority of up to \$150 million. Also, the budget bill does not, at this time, contain the State Building Program, which is approximately \$113 million.

The committee feels very strongly that it cannot comment on the fiscal effects or the appropriateness or desirability of these borrowing programs, unless it can make a recommendation on all borrowing that is to be authorized through the bill. The committee feels that the important component of most effective debt management is to conduct a comprehensive review of all borrowing to be authorized in the bill. Therefore, the committee will prepare a report that includes the additional proposals, at such time as those proposals are submitted in draft form to the joint committee on Finance. That report, it is anticipated, will be transmitted to the Legislature and to the joint committee on Finance, prior to the Finance Committee's final consideration of the bill.
