In enrolling, the following corrections were made:

1. Page 421, line 7: substitute "SECTION 1160q." for "SECTION 1159s."; and move this SECTION to proper numerical sequence in the bill.

NOTE: Reorders SECTION according to statute sequence.

Assembly amendment 4

1. Page 11, line 21: on lines 21, 22 and 24, delete "(1)", "(2)" and "(3)" and substitute "(2)", "(3)" and '(1)", respectively; and move the subsections into proper numerical sequence.

NOTE: Corrects alphabetical sequence of counties in the 35th district.
