Public Policy Involved

The Joint Survey Committee on Retirement Systems notes that the original bill contains technical errors and also would apply to all protectives after the effective date. Therefore, the committee recommends the adoption of senate substitute amendment 1 which corrects the technical omissions, and also provides that the provisions of the bill shall not apply to those protectives who are age 55 or over on the effective date of January 1, 1985. With these changes, the Joint Survey Committee finds that this legislation reflects good public policy and recommends its passage.
