STATE OF WISCONSIN CLAIMS BOARD

The State Claims Board conducted hearings at the State Capitol Building, Madison, Wisconsin on February 20, 1984, upon the following claims:

THE BOARD FINDS:

- 1. William and Claudia Levin of Madison claim \$2,079.10 for water damage to 44 pairs of shoes and miscellaneous items which were stored in claimants' designated basement storage area at the University of Wisconsin Madison Eagle Heights Apartment on August 28, 1983. The water damage allegedly occurred when the building sewer line backed up into the basement. The Board concludes that the claim in the reduced amount of \$500 should be paid based on equitable principles. The Board further concludes, under authority of s. 16.007(6m), Stats., payment should be made from the University of Wisconsin appropriation s. 20.285(1)(h), Stats.
- 2. Francis Hemauer of Conover claims \$500,000.00 as compensation for wrongful imprisonment under s. 775.05, Stats. Claimant requests compensation for his imprisonment for the alleged commission of attempted murder, rape and abduction which crime occurred on October 15, 1968. On September 28, 1972, claimant was found guilty of the alleged crimes and was imprisoned until April 8, 1981, when he was freed by the Hon. Marvin C. Holz on the basis of the results of chemical tests performed on the evidence in the case in 1980, which proved that claimant was not guilty of the crimes. In view of the evidence presented to the Board and the time served by the claimant from September 28, 1972 until April 8, 1981, the Board recommends that the state in good conscience should compensate claimant \$10,000 per year for the time he was incarcerated, because the Board feels that the \$5,000 per year amount for these kinds of claims is inadequate, for a total award of \$85,260.28.
- 3. Milwaukee Mutual Insurance Company claims \$129.88 subrogation damages. Its insured, Mrs. Donald Lane, submitted a claim to the insurance company for damages to her automobile incurred on August 29, 1982, while parked at the Southern Wisconsin Center. The damage was caused by a resident of the Center who ran into the vehicle with his bicycle causing the damages. Consistent with a long-standing policy of this Board concerning subrogation damages, the Board concludes the claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 4. Lana Potisk of Burlington claims \$187.43 for damages to her automobile fender and hood, allegedly incurred at the Southern Wisconsin Center on September 3, 1983, although there were no witnesses as to how the damage was caused. Claimant received \$151.60 from her insurance company for the damage to her vehicle. The Board concludes the claim is not one for which the state is legally liable, nor one which the state should assume and pay based on equitable principles.
- 5. Mitchell Frank of Oshkosh claims \$26 for repairs to his wedding ring allegedly necessitated by an accident on September 7, 1983, at the Wisconsin Resource Center, where he is employed. Claimant was responding to an

inmate trouble call and as he passed through a doorway his ring caught on the door frame plate cutting his finger. As a result, claimant's hand began to swell, necessitating cutting off his ring and later repairing it. The Board concludes there has been no showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.

- 6. Sally Anderson of Fond du Lac claims \$520.28 for repairs of scratches and dents to her automobile allegedly incurred while parked in Sherman Hall parking lot at the Winnebago Mental Health Institute on October 1, 1983, although there were no witnesses and no evidence of how the damage actually occurred. The Board concludes there is no evidence of negligence on the part of the employes, officers or agents of the state and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 7. Lynette Danford of Waukesha claims \$75 for damage to her vehicle windshield incurred while she was driving on Highways 164 and 190 near Pewaukee, WI on June 13, 1983. A stone was thrown against her windshield from the tire of a state vehicle painting stripes on the highway. Claimant originally tried to repair the windshield at a cost of \$25 and subsequently had the windshield replaced at a cost of \$133.64. Claimant received \$83.64 from her insurance company for replacement of her windshield. The Board concludes the claim in the reduced amount of \$50, which is the amount of claimant's insurance deductible, should be paid based on equitable principles. The Board further concludes, under authority of s. 16.007(6m), Stats., payment should be made from the Department of Transportation appropriation s. 20.395(3)(hq), Stats.

THE BOARD RECOMMENDS:

1. Payment of \$85,260.28 be made to Francis Hemauer as compensation for his wrongful imprisonment from September 28, 1982 until April 8, 1981. The Board recommends payment of \$10,000 per year for the time claimant was incarcerated because the Board feels that the \$5,000 per year amount provided for these kinds of claims under s. 775.05, Stats., is inadequate.
