# STATE OF WISCONSIN CLAIMS BOARD

The State Claims Board conducted hearings at the State Capitol Building, Madison, Wisconsin on May 23, 1984, upon the following claim:

1. Elwin Donaldson of Madison claims \$6,038 for attorney fees, \$68 for school tuition fees, \$25 for counseling fees and \$18,869.00 for mental anguish, depression and anxiety incurred as the result of his wrongful arrest, conviction and imprisonment for the alleged commission of an armed robbery on December 7, 1980. On December 7, 1980, Jay Hoffman, who was passing through Madison on his way to Texas, informed Madison police that he had been robbed at gunpoint by two men on East Main Street in Madison. Jay Hoffman later identified the claimant as the perpetrator. Claimant was convicted of the armed robbery charge in Dane County Circuit Court on February 19, 1982. At all times claimant maintained his innocence. Claimant was in jail from February 19, 1982, awaiting sentencing until mid-April, 1982, when he was freed because Jay Hoffman admitted he had fabricated the entire complaint against the claimant. The Board recommends that the state in good conscience should compensate claimant in the amount of \$25,000 which includes the out-of-pocket expenses for attorney fees, school tuition and counseling fees, based on equitable principles.

### THE BOARD FINDS:

1. Payment of \$25,000 be made to Elwin Donaldson as compensation for his wrongful conviction and imprisonment for the alleged commission of an armed robbery on December 7, 1980.
