STATE OF WISCONSIN CLAIMS BOARD

The State Claims Board conducted hearings at the State Capitol Building, Madison, Wisconsin on May 23, 1984, upon the following claims:

THE BOARD FINDS:

1. Odell Hardison of Waupun claims \$2,379.00 for replacement cost of jewelry allegedly held by the Kettle Moraine Correctional Institution, where he was

incarcerated, since 1977. Some of the items have been returned to claimant. The Board recommends payment of this claim in the reduced amount of \$575.00 for reimbursement of the unreturned property, based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.435(3)(a), Stats.

- 2. Hy Dorosin of Chicago, Illinois, claims \$7,900.44 for payment of 500 dozen cloth diapers supplied to the Southern Wisconsin Center in 1982. During early 1982 diapers at the Southern Wisconsin Center were deteriorating in the wash which had been performed by Adelman Laundry. At that time, Adelman agreed to replace the diapers. The Southern Wisconsin Center then contracted with claimant to provide 500 dozen diapers at a cost of \$13.25 per dozen and the Center has received the diapers from claimant. Later in 1982, Adelman underwent a management change and the new management claimed the state was being unjustly enriched under the replacement diaper agreement since the diapers were in varying stages of their useful lives. To date, claimant has not received any payment on the diaper order. The Board recommends the state in good conscience should compensate the claimant in the amount of \$7,900.44 based on equitable principles. The Board concludes under authority of s. 16.007(6m), Stats, payment should be made from the Department of Health and Social Services appropriation s. 20.435(2)(gk), Stats.
- 3. John Stebbins, Jr. of Milwaukee claims \$560.14 for the amount of insurance premiums and \$437.32 for his time spent pursuing his claim incurred as the result of the deduction of health insurance premiums from his payroll checks dated October through December, 1982, by the University of Wisconsin-Milwaukee, where he is employed. In April, 1982, after conversations with the University Staff Benefits Office, claimant chose to enroll in a University health insurance plan which provided 90% state contribution towards the health insurance. Claimant was eligible for the 90% state contribution because of the combination of his LTE employment and an academic staff appointment resulting in greater than 50% employment with the University of Wisconsin-Milwaukee. In the fall of 1982, claimant worked as an LTE but his academic staff appointment at the University was paid in a lump sum. Since no percentage of time was assigned to that work, the University interpreted claimant's employment as less than 50% and therefore, he was not eligible for the 90% state contribution for health insurance. However, claimant's academic staff appointment and time involvement remained the same. The Board concludes that the the claim should be paid in the reduced amount of \$560.14, representing the amount of the insurance premiums deducted, based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats, payment should be made from the University of Wisconsin appropriation s. 20.285(1)(a), Stats.

- 4. Frank Schaeffer of West Bend claims \$122.00 for reissuance of a stale dated check pursuant to s.16.007(6)(b), Stats. The check was originally issued out of the Department of Industry, Labor and Human Relations Unemployment Reserve Fund Benefit Account under s.108.16(6), Stats. Under that section, a check may be reissued any time within the next following year, if the check has not been presented for payment within one year after its date of issue. The Board finds that payment of this claim at the time would circumvent current legislative policy. The Board concludes this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 5. Frederick Oby of Milwaukee claims \$189.00 for the replacement cost of his wedding ring allegedly lost in September 1983, during the course of his duties as an employe of the University of Wisconsin-Milwaukee. Claimant was applying a straw mulch to a newly seeded area at the University of Milwaukee Chancellor's residence when his ring flew off. The Board concludes there is an insufficient showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 6. Kevin Wagner of Poynette claims \$109.95 for replacement cost of his eyeglasses which were damaged on November 9, 1983, while he was herding pheasants at the State Game Farm in Poynette as part of his duties as an LTE employe of the Department of Natural Resources. The pheasants flew at claimant knocking his glasses from his head. The Board concludes the claim should be paid based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats, payment should be made from the Department of Natural Resources appropriation s. 20.370(1)(mu), Stats.
- 7. Orville Olson of Fence claims \$51.00 for the loss of poultry which were allegedly killed by wild mink on his farm on October 13, 1983. Even though legal title to all wild animals in Wisconsin is vested in the State pursuant to s.29.02(1), Stats., mere ownership does not create legal liability for damages done by wild animals. There is no showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- 8. Wayne Ruenger of Fox Lake claims \$63.00 for the replacement cost of his clothing which was damaged on February 16, 1984, by battery acid when a battery exploded while he was performing his duties as an employe of the Department of Health and Social Services at the Waupun Central Warehouse. The Board concludes the claim should be paid based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats, payment should be made from the Department of Health and Social Services appropriation s. 20.435(8)(k), Stats.

- 9. James Fehling of Beaver Dam claims \$41.00 for damage to his clothing incurred on February 16, 1984, by battery acid when a battery exploded while he was performing his duties as an employe of the Department of Health and Social Services at the Waupun Central Warehouse. The Board concludes the claim should be paid based on equitable principles. The Board further concludes under authority of s. 16.007(6m), Stats, payment should be made from the Department of Health and Social Services appropriation s. 20.435(8)(k), Stats.
- 10. James O'Brien of Milwaukee claims \$2,323.30 for attorney fees and bank charges incurred when his 1981 state and federal tax returns were intercepted by the Department of Health and Social Services pursuant to ss. 71.105 and 46.255, Wis. Stats. Upon notice of the interception, claimant could have contacted the Child Support Agency, the Family Court Commissioner, or the Department of Health and Social Services' Office of Economic Assistance for assistance in appealing the tax intercepts. The Board concludes there has been no showing of negligence on the part of the state, its officers, agents or employes and this claim is not one for which the state is legally liable nor one which the state should assume and pay based on equitable principles.
- The claim of Lynn Oestreich was previously approved for payment at the April 30, 1984 Claims Board meeting in the reduced amount of \$1,000.00. The Board approved payment of the claim in the reduced amount so that payment could be issued to claimant without legislative approval. The claimant was unwilling to accept \$1,00.00 as full and final settlement of this claim. The Department of Health and Social Services recommends that the claimant be reimbursed the total amount of the moving expenses he incurred. Upon reconsideration, the Board recommends the state should compensate the claimant in the amount of \$1,215.40, based on equitable principles. The Board concludes under authority of s. 16.007(6m), Stats., payment should be made from the Department of Health and Social Services appropriation s. 20.435(3)(a), Stats.
