# State of Wisconsin Department of Revenue

June 29, 1984

To the Honorable the Legislature

Pursuant to Section 2045 of 1983 Wisconsin Act 27, I am forwarding the attached report outlining the fiscal and administrative effects of requiring corporations to file combined income and franchise tax returns.

The study draws heavily on the experience of Minnesota and California, both of which tax multijurisdictional firms under the unitary approach. Our goal is to provide interested legislators with factual information about this matter; thus the report does not include the department's policy judgment on the issue. I will be reviewing the findings of the study as part of the 1985-87 executive budget bill development process and will provide a recommendation later this year within the context of that process.

Major findings contained in the report include the following: (1) An analysis of a select group of 68 large Wisconsin corporate taxpayers and their affiliates, utilizing both Wisconsin and California tax data, suggests that adopting worldwide combination would result in a modest (1.8%) aggregate increase in tax collections from that group of corporations (if complete compliance is assumed); (2) the same analysis also revealed that while the aggregate revenue effect is small, very significant tax shifting occurs among corporate taxpayers; tax liability changes for individual corporations would range from a \$2.2 million tax increase to a \$0.9 million tax decrease, depending on specific circumstances; (3) Minnesota's experience in implementing domestic combined reporting suggests that compliance is incomplete, at least in the early years after implementation, thereby resulting in a revenue loss in the near-term; and, (4) the Minnesota experience also indicates that firms facing net tax liability increases are less likely to comply with provisions of combined reporting (i.e., conversely, corporations experienced reduced taxes using the method are more likely to fully comply), thereby creating a substantial and ongoing tax enforcement challenge that necessitates new training and personnel costs.

The last point bears closer examination if consideration is given to a <u>specific</u> combination proposal. Absent a specific method, any projection of administrative costs would be conjectural because of the many variables involved. These variables are discussed in the report.

In a similar vein, conclusive judgments about the tax collection impact of worldwide combination must be qualified at this point because of the wide range of policy and administrative alternatives that would have to be resolved. However, the experience of Minnesota, which has shown a short-term net revenue decrease, rather than the substantial tax collections increase that had been projected, underscores the need for a cautious assessment of the revenue potential.

We hope that this information offers insights into a complex aspect of tax law.
